

2015 Buccaneers Enter To Win Training Camp Sweepstakes

Official Rules

No Purchase Necessary to Enter or Win. A Purchase Will Not Increase Your Chances of Winning.

- 1) Eligibility: The 2015 Buccaneers Enter To Win Training Camp Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of the following Counties in Florida who are eighteen (18) years of age or older as of the date of entry: Hillsborough, Pinellas, Polk, Pasco, Manatee, Sarasota, Charlotte, De Soto, Highlands, Hardee, Osceola, Orange, Seminole, Lake, Sumter, Hernando, Citrus or Marion (hereafter, "Eligible Counties"). - **2) Promotion Period:** Sweepstakes begins 12:00:00 am (midnight) Eastern Time ("ET") on August 1, 2015 and ends 11:59:59 pm ET on August 19, 2015 (hereafter, "Promotion Period"). The Promotion Period will be divided into eleven (11) individual daily entry periods (each, a "Daily Entry Period"), with one (1) drawing each (each, a "Daily Drawing Period"), as follows:

3) How to Enter: During the Promotion Period, each entrant may receive one (1) entry by completing and submitting the entry form available at http://go.buccaneers.com/2015salessweeps with the entrant's full legal name, address, phone number, and email address. Alternate Method of Entry: Entrants may submit an entry form with the entrant's full legal name, address, phone number, and email address via US mail to Buccaneers Enter to Win Training Camp Sweepstakes, C/O Buccaneers Limited Partnership, One Buccaneer Place, Tampa, FL 33607. All entries must be received by the deadline for the applicable Daily Entry Period (outlined above) to be considered for that Daily Drawing. Incomplete, illegible or mechanically reproduced entries will be void. Only one entry per Daily Drawing Period per name and email address. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, damaged, inaccurate, illegible, postage due or undelivered entries, mail or ballot boxes or for telephonic, human or computer failures, problems or errors, defects or delays in any transmission, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, mail or ballot boxes, the announcement of the prizes or winners, for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants and disqualify such entrants whom Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes and/or who are in violation of these Official Rules.

- **4) Winner Selection:** There will be a total of eleven (11) individual random Daily Drawings conducted by Sponsor, one (1) for each Daily Entry Period for a total of eleven (11) Grand Prize winners (one (1) per Daily Entry Period). The Daily Drawings will be conducted, as outlined in the chart above, throughout the Promotion Period from among all eligible entries received for each applicable Daily Entry Period. The first Daily Drawing will be held on or about August 2, 2015 and the last drawing on or about August 20, 2015. All drawings will be conducted by Sponsor. Odds of winning depend upon the total number of eligible entries received for the applicable drawing. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. Potential winners will be notified at the telephone, mail, overnight mail and/or email. Limit one (1) prize per person per household.

Non-compliance with the foregoing, with these Official Rules, the inability to contact a potential winner within a reasonable time period or the return of a prize or notification as undeliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner for the applicable Daily Drawing.
