ELIGIBILITY:** The Tampa Bay Buccaneers Tackle Everything Sweepstakes (“Sweepstakes”) is open only to legal residents of the states of Florida and Georgia who are 18 years of age or older as of August 30, 2018. Limit one (1) entry per person/email address, per day, during the Sweepstakes Period. All entries become the property of Administrator and will not be acknowledged or returned.

 - Four (4) First Prize Winners:** Prize consists exclusively of: Two (2) Lower Level Tickets, One (1) Parking Pass, and Two (2) Outside Tailgate Passes including free food and (non-alcoholic) beverages. Approximate retail value of First Prize is \$250.00.

Administrator reserves the right to substitute prize of equal or greater value in the event of the prize unavailability. The drawings will be conducted by the Team, whose decisions are final on all matters relating to the drawings. Odds of winning depend on the number of eligible entries received. Administrator's decisions are final and binding on all matters related to this Sweepstakes.
- 5. WINNER NOTIFICATION:** Prize winners will be notified by phone or email, in Administrator's discretion. The Winner is responsible for all federal, state and local taxes, if applicable.
