

2015 Buccaneers Captain Fear Valentine's Day Sweepstakes

Official Rules

No Purchase Necessary to Enter or Win. A Purchase Will Not Increase Your Chances of Winning.

- 1) Eligibility: The 2015 Buccaneers Captain Fear Valentine's Day Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of Hillsborough, Pasco and Pinellas counties in the state of Florida (the "Sweepstakes Territory") who are eighteen (18) years of age or older as of the date of entry. Employees, officers, directors, agents and representatives of Buccaneers Limited Partnership ("Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P. and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. - 3) How to Enter: No purchase necessary to enter or win. All entries must be received by the deadline above. Incomplete entries will be void. Only one (1) entry per name and Twitter handle is permitted. Entries may also be submitted through a Tweet to @THECaptainFear in place of completing the form, using #CaptCupid. Multiple entries submitted by the same name and email address will NOT be permitted.

Sponsor reserves the right to request proof of eligibility and identification of potential winner. Limit one (1) prize per person per household.
