

Season Pass Summer Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Season Pass Summer Sweepstakes (the "Sweepstakes") is sponsored by Buccaneers Team LLC, Adventhealth Training Center, One Buccaneer Place, Tampa, FL 33607 ("Bucs").

Entry Period: The Sweepstakes begins June 3, 2019 at 12:01 AM EST, and ends June 10, 2019, at 11:59pm EST ("Entry Period"). Bucs' computer is the Sweepstakes official clock.

Eligibility: To participate in the Sweepstakes, you must be at least eighteen (18) years of age on the date of entry AND a resident of the state of Florida. Employees of the Bucs or its affiliates, parent companies, marketing agencies, sweepstakes vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Sweepstakes and the immediate family members or those living in the same household of each are not eligible to participate.

There are two ways to enter the Sweepstakes:

1. **2019 Season Pass:** To enter, purchase your 2019 Tampa Bay Buccaneers season pass(es), either by phone at (813) 870-2700 or online at <https://www.buccaneers.com/tickets/season-passes> within the Entry Period. Limit one (1) entry per season-pass account.
2. **Online Entry:** To enter online, enter the following information – name (first and last), phone number, address and email address at https://buccaneers.formstack.com/forms/summer_sweeps within the Entry Period. Limit of one (1) entry per person.

Participation in the Sweepstakes constitutes an entrant's full and unconditional agreement to these Official Rules and Bucs' decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Prize: There is one (1) prize in the Sweepstakes:

Winner will receive two (2) pre-game sideline passes for one (1) Tampa Bay Buccaneers home game (which shall include two (2) general admission tickets into the stadium). The game shall be chosen by the winner from a list provided by the Bucs. The Bucs reserve the right to revoke the sideline passes from winner and/or guest who the Bucs or venue personnel deem, in their sole discretion, may be intoxicated, be a safety risk, or have violated any venue policy or law.

Total Approximate Value of Prize: Four Hundred Ninety Nine Dollars (\$499.00)

The odds of winning depend on the number of eligible entries received.

Winner Selection and Notification: A random drawing for the winner, among all eligible entries received, will be conducted on June 14, 2019, by a Bucs representative, whose decisions are final on all matters relating to the Sweepstakes. Winner will be notified by phone and must respond to the Bucs within five (5) business days. In the event a winner is unreachable or a winner is not in compliance with these Official Rules, the winner will forfeit the prize. The forfeited prize may be awarded to an alternate winner in a random drawing from all remaining eligible entries received for the Sweepstakes.

The winner of the prize will be required to complete and return an Affidavit of Eligibility, a Release of Liability and Publicity Release (the "Affidavit") including, but not limited to, providing proof of identity,

which must be executed and returned to the Bucs within ten (10) business days of the date specified on the notification. If the Affidavit is returned as undeliverable or not returned to the Bucs within ten (10) business days of the date specified on the notification, the prize will be forfeited and may be awarded to an alternate winner in a separate random drawing.

Prize is non- assignable and non-transferable except to a surviving spouse. No substitutions are permitted except if prize is unavailable, in which case a prize of equal or greater value may be awarded.

Prize is not redeemable for cash. Taxes on any prize, including any federal, state, local, sales and income taxes (if applicable), are solely the responsibility of the winner and winner agrees to provide a W-9 Tax form. Winner will not be required to make any payments to the Bucs.

General Conditions:

By participating in the Sweepstakes, entrants also agree that the Released Parties are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; (viii) any unanswered or undeliverable winner notifications; and (ix) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN FLORIDA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN TAMPA, FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
